

## Difficult Conversations: The Role of Information Science in the Age of Human-Centered Artificial Intelligence

Information science scholars and practitioners have anticipated the evolution (and expansion) of artificial intelligence (AI) for decades. AI has been called the "technology of a generation," (UK Government, 2024) and as such, information science scholars will have a significant role in its development and implementation. As the world is now embracing AI in most aspects of life from education, commerce, leisure, physical and mental health care, politics, among others, information science scholars and practitioners should be asking difficult questions about how information science research can be used to benefit society and to guide others to thoughtfully implement the outcomes of our research within numerous contexts.

Information scientists and practitioners have critical roles to play in "leading reflection, debate, and respectful balance" as we consider the global future of Al. Information science should play a greater role in creating policy, theories of ethical information use, and insightful models of information use that can be part of a better solution for Human-Al interaction in these turbulent and complex times.

As the premier international conference in the field, the ASIS&T Annual Meeting is a forum to engage in these difficult conversations, to draw attention to, and learn from each other, as we move research and practice forward in the age of Al. ### MEETING FORMAT

The ASIS&T Annual Meeting remains primarily a face-to-face gathering, and no virtual or recorded presentations will be permitted during the meeting. However, ASIS&T recognizes that there are circumstances that prohibit an individual who might otherwise want to attend the in-person meeting to be unable to attend. To accommodate these individuals, a virtual satellite meeting will be held on December 10, 2025. Papers and posters presented at the virtual satellite meeting will be published in the Proceedings. In the submission form you will be asked to indicate if you are unable to attend the meeting in person and want your submission to be considered for a virtual presentation. All submissions, regardless of presentation format, will undergo the same peer review process.

Circumstances under which virtual presentations will be invited include:

- 1. The individual requesting to present virtually can document or demonstrate:
  - · A disability
  - Prior or anticipated difficulty in obtaining a visa to travel to the US
  - · Significant financial hardship
- 2. There are more high-quality submissions than can be accommodated in the face-to-face meeting.

There will be \$350+ registration fee to attend and present at the virtual meeting. All face-to-face meeting attendees will have access to the satellite meeting at no additional cost.

# SUBMISSION / PRESENTATION LIMITS

In order to maximize the number of people able to attend the Annual Meeting, the planning committee has placed a limit on the number of submissions and presentations permitted per individual. These limits are as follows:

**Posters**. A lead author may submit a maximum of two posters and present a maximum of one poster at the in-person meeting. Should the second submission qualify based on peer review, the author will be invited to preset the poster at the Virtual Satellite Meeting.

Papers: A lead author may submit a maximum of four papers and present a maximum of two papers at the in-person meeting. Should additional submissions qualify based on peer review, the author will be invited to present the paper at the Virtual Satellite Meeting.

Overall Submission and Presentation Limits: One individual may not be the lead author on more than five submissions. One individual may not be the presenter on more than two papers and one poster. In the event that there are co-authors attending the meeting, they may present additional accepted papers/posters so consider changing the presenter should you be making multiple submissions.
